7 It is the Policy of the Stable Door to offer housing to applicants who, for whatever reason, are unable to secure suitable housing through other means. Occasionally, tenants' situations change thus allowing them to vacate Stable Door properties and take up other opportunities. Consequently The Stable Door offers properties on 12 month Assured Shorthold Tenancies and these are reviewed on an annual basis. This allows The Stable Door to re-house further tenants in need of suitable housing if necessary
